- \_\_\_\_\_ By submitting this Application, applicant agrees to indemnify, defend and hold harmless the Washoe County School District, the TITK Committee, the City of Reno, and Idlewild Park ("Sponsors") from any and all liability for any injuries, claims, theft, damage, or loss of property ("Damages") that might occur as a result of vendor's participation in TITK 2008, except for such damages due to the gross negligence or willful misconduct of Sponsors. Vendor shall provide evidence of general liability insurance in the amount not less than 1 million dollars (\$1,000,000) combined single limits for bodily injury and property damage. Such insurance shall name the Sponsors as additional insured and shall provide thirty (30) days notice of cancellation of the policy.
