



# TEENS - N - TUNE T-N-T 2009

## PERFORMANCE AGREEMENT

THIS FORM MUST BE SIGNED BY ALL MEMBERS OF A BAND OR VOCAL GROUP.

If selected to perform in the Tune In To Kids T-N-T 2009 competition, all solo artists or members of a band or vocal group must agree to the following terms and conditions:

- ✓ Please submit a recording of your music along with your registration form. Call if you do not have a recording available.
- ✓ Individual performers must be 18 years old or younger.
- ✓ Any band or vocal group must have a majority of the members under 20 years old.
- ✓ Tune In To Kids is a family event, the lyrics and presentation must be acceptable in that environment. NO profanity or offensive/suggestive behavior will be allowed. Any violation will result in IMMEDIATE disqualification.
- ✓ No parking is available inside the Park-please use the free shuttle from Reno High School.
- ✓ All performers must check in at the Teens-N-Tune Stage at 10:30 am.
- ✓ You must be prepared to perform at the time assigned to your group. That time will be between 11:00 a.m. and 3:15 p.m. If you miss your second call, you will be removed from the competition.
- ✓ **NEW** - The competition will be judged in two rounds for each category: Bands and Vocalists will perform one song each, and then there will be a break where the judges can compile their scores and the three top performers in each category will come back and have two songs each.
- ✓ The judges will give the top performers verbal pointers on how they can improve their performances after the first round.
- ✓ You must follow the direction of the music production team. This team is responsible for your safety and ensuring that the event runs smoothly.
- ✓ Please be properly prepared for your performance. The weather is frequently unpredictable so dress accordingly. If it is cold, dress warmly. If the sun is out, bring a hat and sunscreen.
- ✓ Teens-N-Tune Production Team will provide drums, amps, a mixer, speakers and mics. Bands must supply all other equipment and instruments. Tune In To Kids is NOT responsible for damaged or lost equipment.
- ✓ Singers must supply their music on CD or by iPod.
- ✓ Drugs and alcohol WILL NOT be allowed on the premises and no person under the influence of alcohol or other drugs will be admitted. This includes performers, their crew and friends, or Fair attendees. Violations will result in disqualification and removal. The use of tobacco products is also prohibited.
- ✓ You must be prepared to stay on the Tune In To Kids Fair grounds (Idlewild Park) for the full event so that you can be present and back at the Teens-N-Tune Stage at 3:30 pm when the winners are announced.
